- Charges begin on the day of arrival.
- Check-Out Time is before 11 AM, Mon - Sun. Dogs staying after 11 AM will be charged another day.
- Dogs will be let out twice in both the AM and PM for exercise, and also given a bedtime potty break.
- Baths include nail trims – *if we can do them safely, without stressing your dog, or getting bitten ourselves.* We reserve the right to refuse trimming a dog's nails if we feel it is warranted. The cost of the bath will remain the same.

All dogs must be current on the following vaccinations: Distemper, Hepatitis, Parvo, Bordetella and Rabies, unless accompanied with a letter from the veterinarian stating the dog cannot be vaccinated – We reserve the right to accept or refuse said dog. Valid proof of vaccinations from a veterinarian must be presented before pets can be dropped off for boarding or training. Owner also agrees to keep the dog on heartworm preventative as well as flea and tick preventative. **Pets found to have arrived with fleas/ticks will be immediately bathed in appropriate flea shampoo at owners' expense.**

- Bookings will be cancelled after 24hrs of scheduled drop off date/time if no contact for adjustment/no show.
- We are not responsible for any lost or damaged belongings. Please do not leave any toys or beds that you do not want to get damaged. Dogs may act differently here than they do at home. Please label all belongings.

**SHARED ACCOMODATION WAIVER**

I voluntarily request that CAVK, LLC board my pets in the same run or kennel. I understand this to mean that the animals will be housed together in the confines of the requested accommodation for the duration of their stay, unless problems arise. I hereby voluntarily release CAVK, LLC, its staff and agents from any and all responsibility or liability arising from injury or damage inflicted by one of my pets on another during their stay. I understand that in the event of such injury or damage, I am liable for all charges of medical services provided by CAVK, LLC for treatment of the said injuries or damage. I understand that in the event of aggressive behavior directed against one of my pets by another that the pets will be separated and housed individually for the remainder of their stay. I also understand that I am responsible for any additional boarding charges that may apply under those circumstances. Please sign indicating you have read the above.

**PLEASE READ CAREFULLY:**

CAVK, LLC agrees to exercise due diligence and reasonable care, and to keep the premises and off-site, in-home boarding quarters sanitary and properly enclosed. All dogs are handled or cared for by CAVK, LLC staff without liability on CAVK, LLC part for loss or damage from disease, theft, fire, death, escape, transport, injury or harm to persons, other dog(s) or property by said dog(s), or from other unavoidable causes, due diligence and care having been exercised.

CAVK, LLC reserves the right to refuse any dog.

There is a \$2 per day 'housekeeping fee' for dogs who continually defecate in their kennels. This does not apply to a once-in-awhile accident; this applies to dogs who may not be 'potty' trained or have anxiety issues and defecate **daily** in kennels.

Owner agrees that their pet may be videotaped, photographed, and recorded. CAVK, LLC shall be the exclusive owner of the results and all proceeds of such tapings, photography, and recordings with the rights, throughout the world, and unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The Owner further agrees that the dog may be used in any and all media and in the promotion, advertising, sale, and publicizing CAVK, LLC .

**Emergency Medical Care:**

*The boarding establishment shall bear the expenses of veterinary treatment for any injury the animal sustains while at the boarding establishment, if the injury resulted from the establishments failure, (whether accidental or intentional) to provide the care required by 3.1-796.6b; however boarding establishments shall not be required to bear the cost of veterinary treatment for injuries resulting from the animal's self-mutilation.*

If, in our judgment, your pet requires immediate medical care due to illness or injury, and we are unable to reach you or the emergency contact, we will take your dog to a veterinarian or animal hospital. By signing below, you agree to be solely responsible for the payment of all medical bills for your pet and you release CAVK, LLC , its officers, directors, agents, and employees of and from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

**Financial Arrangements:**

Owner agrees to pay the rate for boarding in effect on the date the pet is checked into CAVK, LLC. Prices are subject to change at any time, without notice. No pet will be released until all charges (including advances for medical costs) are paid in full. CAVK, LLC shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding, day care, and/or training at CAVK, LLC .

Owner shall remain liable for complete boarding bill as well as other charges incurred in the care and maintenance of said listed on this contract. The owner further agrees to be solely responsible for any and all acts or behavior of said pet while in the care of CAVK, LLC . The Owner of the dog agrees to pay reasonable attorney fees incurred by CAVK, LLC in the collections of any boarding, day care, training, or other charges incurred by the Owner of the dog.

There is a \$35 fee for a check returned by the bank, for any reason.

**I certify** that I am the legal owner of the dog(s) being boarded. I assume responsibility for all charges incurred in the care of this animal. I also understand that these charges are due upon drop off/or release of dog. I understand that payment can be made in the form of cash, check, MC, Visa. I fully intend to pick up my dog on the date specified. If circumstances change, I will notify CAVK, LLC of a new pick-up date and will pay in full the charges that were incurred at that time. I understand that if no notification of a delay is given, my dog will be considered abandoned after 7 days and will become property of CAVK, LLC .
