- Charges begin on the day of arrival.
- Check Out Time is 11 Am, Mon - Sun. Dogs staying after 11 AM will be charged another day.
- Kennel supplies high quality dry dog food which is included in the boarding fee. Any special diets (canned food, treats, etc.) must be supplied by owner; however, boarding price will remain the same.
- All dogs must be up to date on the following vaccinations at the time of boarding, grooming, or training: DHLP, PARVOVIRUS, RABIES.
- Dogs will be out AM and PM for exercise, additional playtime available upon request.

BOARDING CONTRACT

We agree to exercise reasonable care and to keep our kennel premises sanitary and properly enclosed. The dog is to be fed and watered properly and regularly and to be housed in clean, safe quarters. We agree to exercise the dog either on leash or in fenced areas each day as designated by the owner.

All dogs boarded or trained or otherwise handled, including animals being groomed by us, are without liability on our part for injury, loss or damage from disease, death, running away, theft, fire, injury to persons, other dogs or property by said dog or any other causes.

If dog becomes ill or dies, dog will be taken to designated vet, or if not available, to on-call vet. Owner will be notified at once. We reserve the right to call a vet, or administer medicine or give other advisable attention within our discretion and judgment. Such expenses shall be paid promptly by the owner of the dog. In case of death, autopsy may be performed at the discretion of the vet.

The boarding establishment shall bear the expenses of veterinary treatment for any injury the animal sustains while at the boarding establishment if the injury resulted from the establishments' failure, whether accidental or intentional, to provide the care required by 3.1-796.68; however boarding establishments shall not be required to bear the cost of veterinary treatment for injuries resulting from the animal's self-mutilation.

If any charges for boarding, training, or grooming, medicines or vet services are not paid within 30 days after they are due, or if dog is not called for within 30 days after time for return of dog, the dog will be sold by us. Notice in writing of such intended sale shall be mailed by certified mail to the owner of dog at the address given by owner in this agreement not less than 10 days before date of such intended sale and no further notice shall be given.

The owner represents that he/she is the legal owner of said dog; that title to said dog is not mortgaged in any way, and that said dog has not to the owner's knowledge been exposed to distemper, kennel cough, rabies or other disease in the last 30 days and that any required license has been obtained.

I, as the owner of the dog or as authorized representative of owner, have read and understand the above information, and agree to all terms and conditions.
